- 1. We need one floor plan per storey and two sections or elevations;
- 2. Floor plans, elevations and sections should follow the style of other drawings in the repertoire (avoid colours and extra information);
- 3. Make sure to provide scale and orientation;
- For better verification, we need the pattern numbers 1–28 noted on the plans (see examples in the repertoire). You can put them on separate layers or provide extra files with numbers;
- 5. Each drawing should individually be saved as a PDF or EPS. The files must contain the vector data;
- 6. Please indicate in the file name the content of each file (storey, section, elevation etc.).

#### 1. Introduction

Your privacy is important to us. - 2. Personal data we collect and how do we use it
  - We collect information by fair and lawful means, with your knowledge and consent. We also let you know why we're collecting it and how it will be used. You are free to refuse our request for this information, with the understanding that we may be unable to provide you with some of your desired services without it.
